FULL DAY MEDIATION (PARENTING)

\$1,680 + GST per parent

- Pre-mediation conference with each party
- Preparation and reading time
- Up to 6.5 hours of mediation (via Teams, Zoom or in person by request)
- Drafting of a Mediation Agreement (for self-represented parties)
- Issuing Section 60I Certificate if applicable

FULL DAY MEDIATION (PROPERTY)

\$1,680 + GST per parent

- Pre-mediation conference with each party
- Preparation and reading time
- Up to 6.5 hours of mediation (via Teams, Zoom or in person by request)

INVITATION TO MEDIATION

\$300 + GST

- Inviting the other party to attend at a mediation
- Issuing Section 60I Certificate if applicable (parenting matters)
- Credited to the mediation fee if scheduled

PERSONALISED PARENTING PLANS

Starting from \$1,625.50 + GST per parent

Includes:

- Individual intakes and review of current family schedules, initial drafting, two rounds of revisions and further correspondence as required between parties
- Final plan delivered within 60 days – ready for legal review, FDR mediation, or to use as a non-binding agreement between co-parents.

FEES, BILLING TERMS, & CANCELLATIONS

FDR Mediation (Parenting) or Mediation (Property)

To secure your mediation date, we require payment in full 7 business days prior to the booked date, or by agreement with your legal counsel.

If Ellie determines that proceeding with FDR Mediation (Parenting)/Mediation (Property) is inappropriate (after conducting pre-mediation conferences with both parties), a \$500 flat fee will be charged to the parties, and the remaining balance will be refunded within 14 business days. A Dispute Resolution Certificate (Section 60I Certificate) will be issued, if applicable, in this circumstance.

Outside 48 hours: If parties wish to reschedule, there's no penalty provided the new mediation is booked and held within 120 days of the original date. The mediation fee will be held in credit by Parenting Matters.

Within 48 hours: The mediation fee will be forfeited in full.

Personalised Parenting Plan

Every plan is custom-built for your family.

We require payment in full 7 business days prior to the booked date, or by agreement with your legal counsel.

This service is non-refundable and non-transferable. Parents agree to the timeline as part of the service commitment (60 days) and will be given an editable copy upon delivery.

Parenting Coordination and Divorce Advisory

Outside 48 hours: If you need to reschedule, there's no penalty provided the new session is booked and held within 14 days of the original date.

Within 48 hours: The session credit will be forfeited in full.

Session credits must be used within 12 months of the booking date.

To secure your PC or Advisory session, we require payment in full 7 days prior, or by agreement with your legal counsel.

Payment for Services

We accept credit cards, direct funds transfer or by arrangement with your legal counsel.
