MEDIATION AND FDR

Room Hire: Charged in accordance with the venue's rate.

Issue of Section 60I Certificates: No charge will apply.

Final Tax Invoices: Final tax invoices are payable in full within seven (7) days of the scheduled mediation date. Payment may be made by credit card, direct funds transfer, or by such other arrangements as may be agreed with your legal counsel.

Cancellations: The mediation fee will not be charged where a cancellation is made more than seven (7) days prior to the scheduled mediation date. Where a cancellation is made within seven (7) days of the scheduled mediation date, the mediation fee will be forfeited.
